



Legal Waiver

This is a Release of Liability, Waiver of All Possible Claims and Assumption of Risks, made by me, the undersigned Releasor, on my own behalf, or on behalf of my child (if Releaser is under 18 years of age), to *The Friendly Financial Coach* for participating in coaching sessions (either in-person or online) offered by this organization. I hereby agree as follows:

- To waive any and all claims that I have or may, in the future, have against *The Friendly Financial Coach*, its directors, officers, members, teachers, and representatives (all of whom are hereinafter collectively referred to as the Releasees)
- To release the Releasees from any and all liability for any loss, damage, injury, or expense that I may suffer, or that my next of kin may suffer as a result of my participation in this coaching program, due to any cause whatsoever, including negligence
- All decisions made by me are my own, and the Releasees will not be responsible for any consequences arising from these decisions
- To hold harmless and indemnify the Releasees from any and all liability for any consequences that may result from my reliance on information given through the coaching service (any reliance I place on such information is therefore at my own risk)
- This agreement shall be binding upon my heirs, next of kin, executors, administrators, assigns, and representatives.
- In entering into this agreement, I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this agreement.
- I freely accept and fully assume all risks, dangers, and hazards and the possibility of personal injury, death, property damage or loss, resulting from my participation in this coaching program.
- I agree to abide by the coaching program policies listed on the website of *The Friendly Financial Coach*. I understand that program policies are subject to change at *The Friendly Financial Coach*'s discretion, and I understand that if I do not abide by these policies, this may result in the disqualification and removal of my participation in the tutoring program.

I HAVE READ AND UNDERSTAND THIS WAIVER AND RELEASE, AND I AM AWARE THAT BY SIGNING THE SAME I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.

I, THE UNDERSIGNED, HEREBY ACKNOWLEDGE THAT I HAVE BEEN ADVISED TO SEEK INDEPENDENT LEGAL ADVICE RELATIVE TO THE REVIEW AND EXECUTION OF THE WAIVER AND RELEASE OF LIABILITIES.

NOTWITHSTANDING THIS ADVICE, I HEREBY WAIVE THAT RIGHT TO SUCH INDEPENDENT LEGAL ADVICE AND THE WAIVER AND RELEASE WITHOUT SEEKING SUCH ADVICE.
